Shady Hollow MUD Meeting Minutes

The MUD Board held its regular monthly meeting on June 1, 2021 in person at 3303 Doe Run and also via tele/video conference.

Deputy Rush stated that six car burglaries were reported on Mother's Day within the District and surrounding ar-

eas. He continued that the Travis County Sheriff's Office was aware of the situation and there would be increased patrols at night.

Mr. Garrett, the District's rate consultant, addressed the Board on the issue of wastewater winter averaging. He explained that winter averaging is a practice by which water use during the winter months is used to determine maximum sewer charges for the upcoming year. He stated that customers can be billed either by volume, based on their actual water consumption, or on a District average. Mr. Garrett continued that generally, with wastewater averaging, a district averages the water usage from the months of January, February, and March to determine an average usage, as during this time outside water usage is a minimum, therefore it provides a more accurate number for indoor usage for averaging.

Director Stried then detailed the history of the District's reacquisition of the System. He reminded those present that in 2013 the District entered into a Strategic Partnership Agreement with the City (the "SPA") in order to delay the annexation of the District by the City. Pursuant to the SPA, the City obtained ownership of the System on April 2, 2018, after which the City began providing water and wastewater services to the customers of the District. He said that full purpose annexation had been planned for December 15, 2020, at which time the City would fully annex the District and acquire all the District's remaining assets and the District would cease to exist. In the meantime, however, SB 1468 was passed which required that an election be held before final annexation of the District. The City then agreed that it would not annex the District and would work with the District to transfer the ownership of the System back to the District. Director Stried stated that during the negotiations for the reacquisition of the System, the District considered how to fund the System. He noted that the District currently had very few funds as the plan prior to the passage of SB 1468 was to spend down the District's money to prevent the acquisition of the money by the City upon annexation. He added that the current rates adopted by the District allowed the District to fund the System going forward.

Mr. Evans, adding to Director Stried's explanation, stated that while the SPA was in place and prior to the City's assumption of the System, the District filed a rate case against the City with the Public Utility Commission regarding the City's overcharging of wholesale water rates to the District. He continued that the District was successful in proving its case against the City, which resulted in a settlement agreement whereby the City agreed to pay the District a one-time payment of \$850,000 as well as to continue to charge the District's retail customers at the same rates that the District charged its retail customers in 2017 (prior to the City's acquisition of the System) until December of 2020, when the City planned to fully annex the District and begin charging City rates. Mr. Evans added that the District used the \$850,000 to provide District customers a credit on their utility billing. He pointed out that the District's subsidized rates, as a result of the rate case with the PUC, are the main reason it appears that the District's rates have suddenly skyrocketed. Mr. Evans then stated that the District is required to adopt rates based on the actual cost of service. He continued that this is the main reason that the District engaged NewGen to help accurately determine the cost of service and the best rate structure to meet those cost requirements.

A discussion ensued regarding the timing of a possible change to the District's rates with regard to **Continued on Page 6**



wastewater. No action was taken on this item at this time. Director Stried noted that the item would likely be revisited in the fall.

The Board renewed the agreement with Environmental Survey Consulting ("ESC"), for management of the Shady Hollow West Nature Preserve. The contract is based on a quarterly term rather than an annual term, with the District's General Manager approving work prior to each quarterly start date to ensure that the District has sufficient funds. The Board reviewed the analytics for the District's website. Director Stried reported that information regarding how to pay your utility bills was added to the website as well as answers to frequently asked questions.

Mr. Swanks reported Tumco had repaired a leak in the system and all other maintenance was routine.

The Board accepted Director Stried's resignation. The Board presented him with a plaque in recognition of his over 25 years of dedicated service to the District, thanked him for his time and guidance during his service, and wished him all the best in his future endeavors. Current Agenda

Citizen Communication

James McFarland - Pipes were frozen during the freeze in February. He has been working on estimates and approaches and would like guidance to the Architectural Control Committee to get approval to have the work completed. Steve Blackney - Requested virtual option for the HOA meetings.

General Managers Report - Amy Loughrey

Administration

- -The HOA office remains closed to visitors, but is still assisting the community via email, phone, and by appointment for HOA services.
- We have received 115 architectural improvement permit requests.
- We currently have \$5,958.52 in outstanding assessments. Assessments are at a 99% collection rate.
- -The HOA issued 26 covenant violation notices in May 2021.
- -The next assessments will go out July 1st and will be due by July 31st.

Parks and Common Areas

GATLING GUN:

- Still seeking and working with vendors for proposals on the landscaping work to complete this park.
- We may plan to remove dead trees after July if they still show no growth.
- We will obtain estimates for the planting of trees to replenish those that may be removed.

CAPISTRANO:

- The majority of landscaping work for this park has been completed. Extensive removal of dead shrubs, etc.

- We replaced most shrubs and added several new crepe myrtles along with a few sprinkles of flowers, mulch, decomposed granite, and black star rock.

- Removal of tree stumps have been completed.

DOE RUN:

- We continue to trim trees in this park that have broken branches from the freeze and recent rainstorms.

- Residents reported misuse of the park by "partying" groups who left various paraphernalia lying in the lower parking lot area. The GM walked the lower park area several times and have not found anything significant but lots of facemasks and sanitizing towelettes along with a few coffee cups strewn about.

- The exercise groups who use the lower parking lot are continuing to enjoy the use - area is in need of a trash can.

SH WEST:

- Two trees were removed in this park.

- The dog park is still doing well. We are still receiving calls thanking the board and HOA for the new dog park.

CAPISTRANO POOL:

- The leak in the main pool was sourced and repaired at a total cost of \$5,400. The wading pool leak was sourced, and repairs were completed at a total of \$1,900.

- The swim season has started off nicely and the maximum capacity at the pool of 75 qty is working out with members having to wait a short period at peak times.

- Lifeguards are adjusting to guarding the wading pool. Sunil Shenoy and the GM both identified children utilizing the pool unsupervised. We have recently installed a new gate lock mechanism. We will also be changing out the depth markers and attempting to improve the beach entry. **SPECIAL EVENTS:**

- Preparations are underway for the Fourth of July. The Shady Lady Event Committee is working hard to organize the event. Doug Allen has agreed to be the Parade Marshal in training. Thank you to Charlie Nettles for the many years of service in this role.

Treasures Report – Geoff Lawson

Bank accounts/Balance Sheet

Our register balance in our Chase Bank operating account as of 5/31/21 was \$440,709.54. The balance was reconciled to the QuickBooks ledger by both the Treasurer and the Heyman CPA firm. Our reserve accounts as of 5/31/21 held \$152,028.82 in our Chase Reserve Account and \$211,282.99 in our CD at TDECU. Our total reserve accounts at 5/31/21 aggregate to \$363,311.81.

We transferred \$8,216.67 from our operating account to our reserve account at Chase Bank in accordance with the funding plan detailed in our Jan 2021 reserve study.

Revenue

- On a Cash Basis presentation, total revenue for the month ending 5/31/21 was \$13,156.65 versus budgeted revenue of \$27,765.
- Assessment revenue for May was less than budgeted because of better-than-expected assessment collections during the previous months. - Once again, facility fees were significantly up for the month of May \$950 versus budget revenue of \$425.

- Once again, racing rees were significantly up for the month of May \$950 versus budget revenue of \$425. - Resale certificate and transfer fee revenue for year to date is currently \$14,800 which is what we had budgeted for the year-to-date period.

- Overall, net loss for May aggregated to -\$35,080.64 versus a projected net loss of -\$15,969.82. This is directly related to the lower than budgeted assessment revenue for the period. Since net income/loss is defined by Total revenues less total expenses. When we have lower than projected revenues it results in a larger than budgeted loss even if expenses remain static. In the case of total expenses for May, we budgeted \$43,734.82 whereas actual expenses were \$48,237.29.

- Under Other revenue at the bottom of the last page note the receipt of \$34,000. This is related to the PPP loan. This has been forgiven, and we are continuing to seek direction from our accountants to address where this should be recognized.

Expenses

- Legal for the month was \$9,165.73 vs budgeted expense of \$2,500 which reflects collection and litigation with our former auditors ramping up. - Acct 66000 "committee expenses" of \$2,792.85 – reflects the traffic committee receipt of speed signs and data collector. This is a budgeted

item for 2021, we didn't know which months they would be purchased.

- Acct 70022 "Repairs and Maintenance" at the pool contains a charge of \$3,188.06 which relates to the final payment for leak detection at both the adult pool and wading pool.

- Acct 81022 "Utilities - Water" at Capistrano pool/park was \$1,099.76 versus budget of

\$406.25. This was higher than normal because of the leak in the big pool and also the higher water rates that were negotiated with the City of Austin (still much lower than if we were in the city)

MRI Expenditures

- There were no expenditures for MRI expenditures for the month of May.

Committee Report

- 1. Executive, Joan Allen Did not meet formally. We were informed on a pending bill regarding Home Owner Associations.
- 2. Finance, Geoff Lawson Did not meet.
- Recreation, Laura Kennedy (GM shared info in Laura's absence) Met at Doe Run Park. Discussed park safety, and possibility of looking into the cost for a gate at the lower parking lot. Also discussed plans and estimates for getting trees replaced. Presentation given from a resident regarding pickle ball on the courts. Reserve study states that the courts will need to be replaced.
- 4. Pool, Sunil Shenoy Met June 16, 2021. Discussed having concessions at the pool. There were some concerns expressed from adult swimmers and their time being constrained. Options were suggested such as opening Monday evening for adult swim. The GM observed the late swim team practice and in her professional opinion the swim team does not impede the adult swim time. Not allowing reserved parties on Sunday evenings was another suggestion.
- 5. Community Center, Russel Downey- Did not meet.
- Welcome, Mary Ellen Mathis Did not meet, but now has some supplies and a list of 16 new homeowners to visit dating back to January.
 Policy, Russell Downy Did not meet.
- 8. Architectural Control, Jason Zirkle Did not meet. Made announcement regarding the Section 6 ACC election. We now have Doug Allen, Jennifer York, and Debbie Peterson as the ACC members in this section.
- 9. Traffic, Clay Zelisko Did not meet. We did get our traffic box in, but there
- 10. Events Committee, Jamie Rygg The Shady Lady Committee is working hard for the 4th of July event. We will have our traditional parade and pool games as well as food and Kona Ice.
- 11. Long Range Planning, Jim Downing (GM shared info in Jim's absence) Did not meet. We have awarded a contract to Survey Works to carry out the survey approved in last month's meeting. We are waiting to hear when they will begin work.

NEW BUSINESS

- Discuss and take action regarding upgrading security measures at the staff office.
 - Due to security incidents that have created an unsafe office environment, we will continue the practice of locking the front door and conducting business in the foyer until the HOA office can be secured. Visitors can call the office or knock on the door for admittance.
 We are looking into making the business office door into a customer service window so that the door can remain locked and for employees only at all times.
 - We are looking into a Ring camera for the front door, a chime, and half door that should all be under \$2,000.
 - No MOTION needed at this time.
- -Discuss and take action regarding adopting Policy prohibiting harassment and other wrongful actions against HOA staff and board members.
