



Shady Hollow MUD Meeting Minutes

The MUD Board held its regular monthly meeting on October 5, 2021 at 3303 Doe Run.

In response to questions from resident Larry Gove regarding water and wastewater rates, Mr. Evans explained that the Board had worked with a rate consultant to set the rates and that all Board members participated in the process. The Board explained the District was in the process of collecting wastewater data for possible wastewater averaging going forward. Resident Karen Taylor stated her belief that more residents should attend Board meetings to be informed about the District's activities. Director Tomme noted that information regarding the time and place of meetings is posted on the District's website and at the community center. The Board discussed citizens' suggestions to increase participation by residents. Resident Kim Schiess made several suggestions regarding possible ways to provide more information to residents in the future.

Deputy Rush explained an incident from September, where an aggressive dog attacked and bit a resident of the Shady Hollow Estates. The dog was later caught and tested for rabies.

The Board briefly discussed its decision to temporarily reduce coverage under the security contract with the Constable's Office because of financial constraints. Constable Suits has notified the county of the revision which reflects a slight decrease in patrol hours.

The Board reviewed the analytics report on the District's website. Director Tomme noted that an article on winter wastewater averaging had been published on the website.

Mr. Swanks reported all facilities within the District were operating as expected. He stated he is working to obtain a quote for a new radar sign on Brodie.





General Managers Report – Amy Loughrey

Administration

- 60-day late notices were sent to 17 members. These members will be assessed a late fee if payment on account is not received by the end of October.
- GM is working on 2022 annual budget items. Several major items have been reviewed and were put out to bid such as insurance, landscaping, and trash services.
- 46 Resale of homes recorded through the end of September 2021 (Revenue for 48 properties on record). We have exceeded the budget for 2021 for fees associated with this process.
- Architectural Permits through September 2021 are 158 qty.

Shady Hollow HOA – Covenants, Conditions and Restrictions:

- The HOA issued 44 covenant violation notices during September 2021. A letter was sent from our attorney to one property owner who the HOA could not locate and notices for requests to comply with CCR for exterior home and yard maintenance were returned in the mail. Currently, the HOA attorney is in communication with the owners to hopefully bring a resolution.

Parks and Common Areas,

GATLING GUN:

- We are scheduled to remove trees and perform tree trimming the first week of November. We are waiting on irrigation estimate from Austin Irrigation Specialists before proceeding with repairs and completing landscaping. Upgrade to electrical power was done to provide electrical for Halloween event.

CAPISTRANO:

- We have an irrigation leak behind the toddler park adjacent to the tennis courts. We anticipate that we may see several additional irrigation lines break over the winter due to the age of our irrigation systems and the intensity of freezes in the area.
- Eagle Scout project for the toddler park is still being coordinated through Bruce Kennedy

DOE RUN/COMMUNITY CENTER:

- We have replaced the emergency EXIT signs and completed fire extinguisher inspections. The windows that were broken by our landscaper have been replaced and re-tinted. The community center is still fully engaged with reservations and requests are still incoming daily for use of the facility. We are still waiting to fully review the estimates received to resurface, re-fence, and upgrade the lighting to the sport court. Proposals will be reviewed for scope of work, accessibility/capability of vendor and overall project estimate.

SH WEST:

- Discount Fence has been scheduled to complete several small repairs on the dog park fence before the warranty expires.

CAPISTRANO POOL:

- The investigation of a pipe leak was found to be a hose bib. The repair was done by our maintenance staff and local resident at a significant savings vs hiring a leak detection firm.
- The pool cabana (restrooms and storage) repairs are underway. We have begun a small amount of remediation for mold that was growing in the attic space and installation of new water heater. The sheetrock and painting will be the next phase.

Treasures Report – Geoff Lawson

Bank accounts/Balance Sheet

Our register balance in our Chase Bank operating account as of 9/30/21 was \$520,152.56. The balance was reconciled to the QuickBooks ledger by both me and the Heyman CPA firm. Our reserve accounts as of 9/30/21 held \$184,906.60 in our Chase Reserve Account and \$211,705.88 in our CD at TDECU. Therefore, total reserve accounts for the period aggregate to \$396,612.48. We transferred \$8,216.67 from our operating account to our reserve account at Chase Bank in accordance with the funding plan detailed in our Jan 2021 reserve study.

Revenue

· On a Cash Basis presentation, Line #2 total revenue for the month ending 9/30/21 was \$62,133.47 versus budgeted revenue of \$37,950.00 Assessment revenue for the period was more than budgeted because of higher assessment collections (\$55,204.53 vs budget of \$35,000.00 and higher resale certificate and transfer fee income (\$3,800 actual versus \$1,900 budgeted)
· Facility fees were significantly up for the month (\$1,450 versus \$400 budgeted)
· Overall, net income for the month aggregated to \$14,066.22 versus a projected net income of -\$17,591.82. The delta between actual and projected net income is the result of higher actual revenue for the period.

Expenses

Professional services expenses (category 60300) were only slightly over budget for the month (\$3,738.75 versus budgeted \$3,400.) Our legal expense was lower than projected for the month (\$1,863.75 vs budgeted amount of \$2,500.00). Accounting expense was higher than normal at (\$1,875 versus budgeted amount of \$900.) Software Subscriptions (category 60510) represents an annual subscription payment for Tops One which is our integrated platform for doing our assessment mail outs/architectural permits/communications/CCR violations. The 2022 budget has been adjusted to indicate that this payment will be due in September. Thereby making our monthly budget more accurate Repairs and Maintenance at the pool (category 70022) had a balance of -\$2,122.40. This reflects our net insurance recovery for the plumbing leak that damaged the ceiling of the pool cabana.
Lifeguard Salaries (category 70120) were \$5,963.48 actual versus budget of \$15,190.00. This variance reflects the early closing of the pool versus the previous year.
